Queens College is seeking a Assistant/Associate Athletics Director/Compliance (SAAC Advisor). This is an senior level position with full time benefits (combination of soft money and state funds) that reports to the Director of Athletics. This position is responsible for facilitating NCAA certification paperwork, maintaining student data in Compliance Assistant (CA), conducting compliance rules education meetings with coaches, writing waivers, assisting with various initiatives to ensure student-athlete eligibility and serving as liaison to Conference office. Sport and area (medicine, strength,, academics, tutoring, etc) oversight, federal reporting and creating and enforcing department policies are also required in this position. This position will also oversee the Student Athlete Advisory Committee (SAAC).
